On completion of the formal introduction, the Principal and Ex-officio member secretary presented the agenda of the meeting for discussion to the members. The minutes of the meeting are given below:

15.01. Confirm the Minutes of 14th Meeting of Governing Body (Board of Management)

15.02. Action taken on the minutes of 14th Meeting of Governing Body held on 30.06.2023

The members have gone through the minutes of the 14th meeting of the Board of Management and ratified the same. The principal has informed that the resolutions passed in the previous meeting such as approval for the revised draft strategic planning for the further period of 6 years with the suggestions of the members has been complied and prepared acordingly.

15.03. To Appraise the Academic Developments

The Principal has highlighted some of the important achievements/activities in academics during the year 2023-24 odd semester.

- A workshop on IPR was conducted by Dr. M. Kanthababu, Professor of Anna University in the college for the benefit of faculty members, PG students and research scholars on 26.07.2023.
- An International Seminar on "Educational Media Production for e-Learning" was conducted on 20.09.2023 in collaboration with NITTTR, Chennai.
- A FDP on "Instructional Design and Delivery System" by NITTTR Chennai, was conducted in the college from 5.10.2023 to 10.10.2023 for the benefit of new faculty members.
- Graduation Day is to be held on 9th December 2023 Dr. N. Chandrasekar, Vice Chancellor of Manonmaniam Sundaranar University, Tirunelveli has been invited to present the degree certificates to the Graduated students of the year 2023.

• Seven candidates have been admitted to Ph.D programmes of various department in July 2023 session. As on date in total 88 candidates are pursuing Ph.D in the college.

- Two candidates, S. Jeevitha (14.08.2023) and M. Swarna Sudha (03.11.2023) of ECE research center, have completed Ph.D viva-voce and qualified for the degree during the period 2023-24 odd semester.
- A faculty member of the college, V. Selvakumar of CSE department has completed Vivavoce examination on 6.11.2023 and has qualified for Ph.D degree.
- 73 research papers have been published in the reputed journals during the calendar year 2023 as on date. Scopus h-index of the college is 29. Google Scholar h-index is 56. The Total number of citations is 3976 (Scopus) & 14172 (Google Scholar)
- Faculty members have published 6 books/book chapters during the calendar year 2023 as on date.
- Faculty members have filed/published 22 patent applications in the calendar year 2023 as on date.
- Three patents have been awarded to the college during the 2023-24 odd semester: 1). Sustainable Fibre Reinforced Foam Concrete Interlocking Block (Patent No: 437026), Date of Filing: 21.12.2022, Date of Grant: 03.07.2023, 2). Ultrasonic Milk Analyser (Patent Design No: 390401-001), Date of Filing: 16.07.2023, Date of Grant: 12.10.2023, 3). Sustainable Recron Fibre Reinforced Concrete Using Marble Sludge Powder (Patent No: 473079), Date of Filing: 19.04.2022, Date of Grant: 24.11.2023. In total, the college has received five number of patents as on date.

As on date about 37% of the students have been placed through the campus recruitment.
