



In the Order second read above, the Hon'ble Supreme Court of India in its order, dated 17.10.1994 in I.A.No.20 in W.P.(C).No.317/93, filed by TMA Pai Foundation and others, have stayed the operation of all the decrees / orders which might have been given by any Civil Court in respect of the minority status to the Institutions concerned and directed that the institutions claiming minority status shall approach the Government for a declaration, that they are minority institutions and till such time, the Government issue an order declaring that it is a minority institution, they cannot operate as Minority Institutions. The 11 Judges constitution Bench of the Supreme Court of India in its judgment dated 31.10.2002 in the same case has laid down certain laws relating to aided / unaided Minority / non-minority educational institutions. However, with regard to the framing of 'indicia' for treating an educational institution as a Minority institution, the Supreme Court has held that it will be dealt with by a Regular Bench.

- 2. In the Government letter fourth read above, the Government have granted continuance of minority status (Linguistic / Telugu) to P.S.R. Engineering College, Sivakasi, Virudhunagar District run by P.S.Ramasamy Telugu Minority Educational & Charitable Trust, Virudhunagar for a period of five years from the year 2012 -2013 to 2016-2017.
- 3. The Commissioner of Technical Education in his letter sixth read above has sent the proposal of Principal, P.S.R. Engineering College, Sivakasi, Virudhunagar District for granting of continuous of Minority Status (Linguistic/Telugu) for a further period of five years from 2017-2018 to 2021-2022. The Government have examined the proposal of the Commissioner of Technical Education, as per the orders issued in the Government Orders first and third read above and in the light of the orders of the Hon'ble Supreme Court of India in second read above, and it is found that:
  - a) P.S.Ramasamy Telugu Minority Educational & Charitable Trust, Virudhunagar, which runs P.S.R. Engineering College, Virudhunagar District has been registered on 16.4.1998. The registration No. is 70.
  - b) The above college has got grant of approval from All India Council for Technical Education directly and affiliated to Anna University.
  - c) The Revenue Divisional Officer, Sivakasi certified that all the members of the Trust belong to the concerned minority (Linguistic / Telugu).
  - d) The Supplementary Deed of the Trust provides that it subserve the interest of the concerned Telugu Minority Community.
  - Out of the total sanctioned strength for the year 2016-17, the percentage of Telugu minority students admitted by the college is 11.58%.
  - 4. The Government after careful examination, have decided to accept the proposal of the Commissioner of Technical Education.
