ITEM NO #6: Institute Financial Assistantship to Full time Ph.D Scholars

Principal has proposed a financial assistantship of max. Rs. 1.2 Lakhs per year to the enrolled Full Time Ph.D candidates in the research centres of the college for a period of maximum 4 years from the date of enrolment. The same may be renewed every year based on the satisfactory performance of the candidates.

After discussion, the members have appreciated the Institute financial assistantship to the full time Ph.D scholars and approved the financial assistantship of Rs 1.2 Lakhs per annum for the same.

ITEM NO #7: Institute Scholarships / Fee Concession for the admitted meritorious / economically backward students

Principal has initiated a discussion on providing scholarships / fee concessions for attracting meritorious candidates in admission and also to support economically backward students. This is being practiced for the past several years. He invited the members' suggestions for extending the above support for the students being admitted in the year 2021-22 also.

After discussion, the members have appreciated the scholarships / fee concession provided to the students based on their merit and poor financial background. Also, suggested that the admission committee shall recommend for financial assistance case by case to the college management.

ITEM NO #8: Incentive / Honorarium to NCC officer

Self-Support NCC unit is functioning in our college with 50 Cadets. The Principal has proposed to provide an honorarium of INR 2000/- per month as per the norms to NCC Officer who is leading the NCC unit.

After discussion, the members have appreciated and approved for the proposal to provide an honorarium to NCC Officer of the college NCC Unit as per the norms.

After discussion, the members have approved a budget to meet out the financial expenses for NCC activities and recommended a maximum of Rs.3000/- per NCC cadet per year for the approval of Finance Committee.
